EXHIBITOR REGISTRATION

Each tabletop exhibit includes one six foot by 30 inch draped table, two chairs, exhibitor ribbon, identification sign and listing in the final program. Exhibitors are responsible for state sales tax on items sold at the meeting.

BENEFITS

NFMA provides the exhibitor one complimentary convention registration to continue networking with attendees for the meeting's duration. (Additional representatives will be charged exhibitor registration fees.) NFMA leadership will recognize each exhibitor from the podium in the opening general session. NFMA will provide attendee post-conference mailing lists to exhibitors. *A description of exhibitor's product, service or company will appear in the on-site printed convention promotion. *Exhibitors will be listed on the NFMA website 30 days prior to and 30 days post convention.

EXHIBITOR REQUIREMENTS

We ask each exhibitor to offer a door prize item with a \$100 minimum value. Attendees will be required to visit each exhibitor to qualify for the door prize. NFMA will award all door prizes at the end of the exhibit on Tuesday evening and winners must be present to claim their prize. Exhibitors are free to offer other samples and novelties in addition to the door prize. Please do not offer discounted services or products for the door prize. Exhibitor is asked to supply shipping if requested by winner.

SET UP

Exhibitors may set up after 2 p.m. If electricity is required, NFMA will bill at the hotel rates for electrical services. Electrical needs must be pre-ordered. Contact Gail Barron at 1-800-433-3532. Exhibitors are required to dismantle their exhibit at the close of the marketplace. The tabletop display will not be secured. NFMA will not be liable for damage or loss to exhibitor's property. Nothing can be attached to hotel property besides the tabletop without permission from the hotel and NFMA.

EXHIBITOR SPACE ASSIGNMENT

NFMA will assign exhibit space location on a first-come, first served basis, if full payment has been received. NFMA reserves the right to determine final exhibit space assignments, and to accept or reject any exhibit.

SHIPPING

All boxes to be sent must be marked NFMA and sent c/o Convention Services, Luxor Las Vegas, 3900 Las Vegas Blvd. South, Las Vegas, NV 89119-8640. Exhibitor will be billed any shipping charges incurred to NFMA.
